

# CORRESPONDING SECRETARY

# REMINDER

Chapter renewals received after January 30, 2014 will require re-certification (payment of \$25.00 plus \$20.00 per member).

Members added less than 30 days of a sanctioned tournament will not be qualified to play in that tournament.

#### **PINOCHLE TIPS AND RULES**

- 1. The penalty for playing at the incorrect table is 100 points.
- 2. Player 'B' wins the book but plays to the board before turning over the book. Another player realizes that he/she has reneged

on the open book, he/she is allowed to correct the play because the book has not been turned.

- 3. Please be sure to read and understand the infractions with emphasis of using abusive language and/or being disorderly. Refer to Infraction #9 for penalties for 1st, 2nd and 3rd occurrence of the offense.
- 4. The cards are to be cut only one (1) time. This is to be done by the upper portion of the deck being lifted clear of the lower portion of the deck leaving no less than four (4) cards in the lower portion of the deck.

NPA CODE OF CONDUCT

Inasmuch as the **NPA** subscribes to Pinochle as a form entertainment. where adversaries are encountered for the length of a game, but friends are for a lifetime, where skills can be nurtured, competition cherished. trophies won. braggarts humbled, and fellowship revered...

- (1) Because we respect Pinochle as a game of skill, we will refrain from any form of cheating...
- (2) We shall strive to enjoy the game as much as possible...make all efforts not to distract other players...
- (3) We recognize that comments made by onlookers can be distracting so we pledge to eliminate comments and jesters when we are spectators.
- (4) We recognize that there are various skill levels and various approaches to the game. We, therefore, pledge to minimize comments regarding mistakes or difference of opinions on strategy, so as not to embarrass or to be overbearing.
- (5) We recognize that there are other Pinochle organizations...
- (6) We recognize that local organizations will vary by size, resources, etc. We will make every effort to assist the host organization in making its organization successful. We further pledge not to make tournaments a contest between local organizations, nor shall we compare one tournament's activities to another.
- (7) We recognize that there are Pinochle novice players and individuals who want to learn the game...
- (8) We recognize that in the course of human interaction, individuals will periodically have

problems relating to others. We pledge that personal difference will remain outside of this organization.
